5. Bids must be submitted to Mailka Rural Municipality, Arkhawang, Gulmi on or before 12:00 Hrs 2083/06/07 (23rd Sept., 2026). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders representatives who choose to attend at **respective date and time** at the office of Malika Rural Municipality, Arkhawang, Gulmi.
7. Bids must be valid for a period of (A/C to bid documents) days counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (Ga-3 Sthaniya Taha Dharauti Khata (Malika Ga. Pa.), A/C No.: **36004010000004**) on behalf of Malika Rural Municipality, Arkhawang, Gulmi or bid bond authorized from a recognized commercial bank of Nepal, which shall be valid for minimum 30 days beyond the bid validity period.
8. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
Whereas under the Single Stage, Single Envelope Procedure, Bidders are required to submit mandatory documents and price bid in one Sealed Envelope as per the provision of ITB 18 of the Bidding Document.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
